ADMINISTRATION OF LOCAL GOVERNMENT

BY THE BLESSINGS OF ALMIGHTY GOD

MAYOR OF BOGOR,

- Considering : a. that in the context of arrangement of regional legislation within the Government of Municipality of Bogor based on evaluation results and in order to support bureaucratic reform program, it is necessary to repeal several Regulations of the Municipality of Bogor;
- b. that based on consideration as referred to in point a, it is necessary to issue a Regional Regulation on Repeal of 7 (Seven) Regional Regulations Governing Administration of Local Government;
- Observing : 1. Article 18 section (6) of the 1945 Constitution of the Republic of Indonesia;

Law Number 16 of 1950 on Formation of Large Cities in Provinces of East Java, Central Java, West Java, and in the Special Region of Yogyakarta (State Bulletin of the Republic of Indonesia of 1950 Number 45) as amended by Law Number 13 of 1954 on Amendment to Law Number 16 and Number 17 of 1950 (Previous Republic of Indonesia) on Formation of Large Cities and Small Cities in Java (State Gazette of the Republic of Indonesia of 1954 Number 40, Supplement to the State Gazette of the Republic of Indonesia Number 551);
3. Law Number 28 of 1999 on State Administration that is Clean and Free from Corruption, Collusion, and Nepotism (State Gazette of the Republic of Indonesia of 1999 Number 75, Supplement to the State Gazette of the Republic of Indonesia Number 3851);

Law Number 12 of 2011 on Legislation Making (State Gazette of the Republic of Indonesia of 2011 Number 82, Supplement to the State Gazette of the Republic of Indonesia Number 5234) as amended by Law Number 15 of 2019 on Amendment to Law Number 12 of 2011 on Legislation Making (State Gazette of the Republic of Indonesia of 2019 Number 183, Supplement to the State Gazette of the Republic of Indonesia Number 6398);

HAS DECIDED:

To issue : REGIONAL REGULATION ON REPEAL OF 7 (SEVEN) REGIONAL REGULATIONS GOVERNING ADMINISTRATION OF LOCAL GOVERNMENT.

Article 1

At the time this Regional Regulation comes into force:

- a. Regulation of the Municipality of Bogor Number 11 of 1987 on Acceptance of Third Party's Contributions to Regions (Regional Gazette of the Municipality of Bogor of 1988 Number 3);
- b. Regulation of the Municipality of Bogor Number 10 of 1990 on Collection of Local Taxes/Local Levies with Forcing Letters in Region of Level II Municipality of Bogor (Regional Gazette of the Municipality of Bogor of 1990 Number 1);
- b. Regulation of the Municipality of Bogor Number 18 of 1999 on Numbering of Houses and Buildings in Region of Level II Municipality of Bogor (Regional Gazette of the Municipality of Bogor of 1999 Number 2);

- c. Regulation of the Municipality of Bogor 12 of 2007 on Regional Civil Servant Investigators (Regional Gazette of the Municipality of Bogor of 2007 Number 6);
  - d. Regulation of the Municipality of Bogor Number 10 of 2008 on Tax Collection Fees (Regional Gazette of the Municipality of Bogor of 2008 Number 4);
  - e. Regulation of the Municipality of Bogor Number 11 of 2012 on Establishment of Community Institutions in Villages (Regional Gazette of the Municipality of Bogor of 2012 Number 4); and
  - f. Regulation of the Municipality of Bogor Number 15 of 2012 Water Resources Management (Regional Gazette of the Municipality of Bogor of 2012 Number 8, Supplement to the Regional Gazette of the Municipality of Bogor of 2012 Number 54);
- are repealed and declared ineffective.

#### Article 2

This Regional Regulation comes into force on the date of its promulgation.

In order that every person may know hereof, it is ordered to promulgate this Regional Regulation by its placement in Regional Gazette of the Municipality of Bogor.
